## WAIVER & RELEASE FORM FOR HAMMOND MILL BIBLE CAMP

### Liability Release and Parental Consent Form

*In order for my child to participate in Hammond Mill Bible Camp, I hereby waive, release, and discharge any and all claims for damages for personal injury, and property damages or which may hereafter occur to me as a result of participation in said event. This release is intended to discharge in advance the Hammond Mill Bible Camp, Hammond Mill Camp, National Forest Service, its officials, officers, employees, volunteers and agents from liability, even though that liability may arise out of perceived negligence on the part of persons mentioned above. It is understood that some recreational activities involve an element of risk or danger of accidents, and knowing those risks, I hereby assume those risks. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assignees. I give consent for my child to participate in the above activities, and I execute the above liability release on their behalf.*

### Consent for Treatment

*I hereby give my consent to have the above applicant treated by emergency medical personnel, a physician, or surgeon, in case of sudden illness or injury while participating in the above activity. It is understood that Hammond Mill Bible Camp will provide no medical insurance for such treatment, and that the cost thereof will be at my expense.*

### Consent for Media Release
